Seminar objectives

The seminar elaborates on key substantive and procedural developments in cartel enforcement. It introduces to participants a general substantive framework for collusive behaviour between competitors by tackling key economic and legal concepts that underpin cartel enforcement. Furthermore, it elaborates on specific forms of cartels, in particular price-fixing, purchasing, bid-rigging and wage-fixing cartels, through a number of case studies from the practice of national competition authorities. Special emphasis is given to the assessment of evidence in the context of judicial review.
